

HOLIDAY INN SYDNEY AIRPORT'S 'PARK STAY & GO' COMPETITION TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is open to all residents of Australia. Employees of the Promoter and their immediate families, and agencies associated with this promotion are ineligible to enter. If an entrant is under the age of 18 years they must obtain consent from their parent or legal guardian prior to entering the promotion.
3. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these Terms and Conditions.
